**ORDER:-**

In the G.O. first read above the Government have issued orders, according permission for reclassification of land to an extent of 164.26 acres in S.F. NOs.163 pt (extent 86.78 acres) in Reddipatti Village and S.F. Nos.1/3, 2/3 (extent 77.48 acres) in Kaminayakkanpatty Village, Salem Local Planning Area, from Agricultural use zone (Protected Mines) into General Industrial use zone in the approved Master Plan for Salem Local Planning Area, subject to the condition that, M/s. ELCOT has to take the responsibility for the stability of the soil and the buildings proposed to be constructed in the land, since the reclassification is requested for the land with made up soil and also 200' wide proposed 'AA' road in the Master Plan should be formed.

2. The Director of Town and Country Planning in his letter 2<sup>nd</sup> read above informed that in the G.O.114, Revenue (LD 7) Department, dated 07.03.2007 , the following details are given:

S.F. No.1/3	-16.39 hec. (40.48 acres)
S.F. No.2/9	-14.98 hec. (37.00 acres)
S.F. No.163/1	35.13.5 hec (86.78 acres)
Total extent	164.26 acres

In the light of the above orders of the Government, the Director of Town and Country Planning, has requested the Government to amend the G.O. 1<sup>st</sup> read above duly substituting expressions S.No.163 pt and S.F.2/3 with S.F. No.163/1 and 2/9 respectively.

3. The Government after careful consideration accept the proposal of the Director of Town and Country Planning in para 2 above.

4. Accordingly, the Government issue the following amendment to the G.O. 1<sup>st</sup> read above.

In para 1 of the said G.O. for the expression "S.F. No.163 pt", the expression "S.F. No.163/1" and for the expression "2/3", the expression "2/9" shall be substituted.
