Your Directors are pleased to present the Thirty second Annual Report of the Company for the year ended 31<sup>st</sup> March 2009 - the Twenty ninth year of its operations.

**DIVIDEND:**

The directors have proposed to declare 5% dividend of Rs.129.65 lakhs on the paid up capital of Rs.2593.05 lakhs.

**THE MAIN ACTIVITIES OF THE CORPORATION ARE AS FOLLOWS:****1. IT PARKS PROMOTION IN TIER II CITIES**

As per the policy directive of Government of Tamil Nadu, ELCOT is promoting Information Technology Parks in Chennai and in the Tier II Cities. Integrated Information Technology Campuses consisting of Information Technology buildings as well as Residential and Social Infrastructure facilities will be established in Tier-II Cities such as Coimbatore, Madurai, Tiruchirapalli, Tirunelveli, Salem and in Hosur.

It is proposed to construct one million sq.ft. TIDEL like IT Tower in all IT SEZ with Social Infrastructure subject to SEZ rules through Public Private Partnership (PPP) mode. The preparation for selection of Private Partner is under progress for all IT SEZ in Tier II Cities.

**2. FREE DISTRIBUTION OF 14” COLOUR TELEVISION SETS:**

The Government of Tamil Nadu has launched a unique scheme of Free distribution of Colour TV sets to the house holds who are not having Colour TV sets. This scheme was commenced during September 2006 to commemorate the birth anniversaries of Arignar Anna on 15<sup>th</sup> September and Thanthai EVR Periyar on 17<sup>th</sup> September.

Elcot has already completed the distribution of 30000 colour Television sets under phase I, 25 lakhs Colour Television Sets under Phase II and 37.50 lakhs sets under Phase III to the households in Tamil Nadu under the Free Colour TV scheme announced by the Hon'ble Chief Minister of Tamil Nadu. Phase IV distribution of 43.56 Lakhs Television sets has already been started. The Government have released a sum of Rs. 673.16 crores so far to ELCOT towards the supply of Colour Television Sets under Phase IV.

### **3. E-GOVERNANCE INITIATIVES OF ELCOT**

ELCOT is involved in development of e-Governance applications and software support for the following departments:

1. Reginet (Registration Department)
2. Employment and Training Department

4. Family Card Project (Civil Supplies Department)

6. Corporation of Chennai

#### **4.1 State Data Centre**

In order to provide a solid backbone to the e-Governance initiatives of the state projects it has been proposed to set up a Data Centre at ELCOT Perungudi premises. Data centre is an infrastructure where the entire state's server infrastructure will be positioned from where the entire state developments will have access. The citizens also will have access to the Data centre resources through appropriate application software hosted from there. ELCOT 's Data Centre will host the Servers of all the departments which opt for the centralised hosting facility. Already the Data centre infrastructure has been commissioned.

#### **4.2 Training Infrastructure Facility**

ELCOT had set up 25 user computer network with necessary UPS and other infrastructure in each District collectorate for providing the necessary training to staff of the Government Departments.

### **5. TAMIL NADU STATE WIDE AREA NETWORK (TNSWAN)**

Tamil Nadu State Wide Area Networking project is the core back bone network project to provide integrated data / internet /intranet, voice communication with in Government offices right up to block level which will provide secure connectivity to run the e-Governance applications of Government and will improve the service delivery in more transparent manner to the citizen. The project implemented

through ELCOT is currently taking off in all the 708 locations of Tamil Nadu including all the 30 District Collectorates. Infrastructure development in all the 708 locations is almost completed. The project has commenced its boot operation from 1.12.2007.

## **6. PROCUREMENT ACTIVITIES**

ELCOT has adopted an innovative procurement policy by encouraging competition among the vendors coupled with an open and transparent procurement process. ELCOT had achieved a price reduction of 20-30% of the market value of the products, thus saving crores of rupees of Government departments.

During the year 2008-09, ELCOT procured IT products for a value of Rs.105.36 Crores and projected for Rs.250.00 Crores for the year 2009-10.

## **7. PARTICIPATION IN NATIONAL AND INTERNATIONAL EVENTS:**

To promote Tamil Nadu as a preferred Destination of Choice for IT and ITES investments ELCOT has participated in the following major National / International events:

1. NASSCOM HR summit 2008 held at Chennai 3<sup>rd</sup> and 4<sup>th</sup> July 2008.
2. CONNECT 2008 event held at Chennai from 11<sup>th</sup> to 13<sup>th</sup> September 2008
3. CONNECT Madurai held at Madurai on 5<sup>th</sup> and 6<sup>th</sup> December 2008
4. Pravasi Bharatiya Divas held at Chennai from 7<sup>th</sup> to 8<sup>th</sup> Jan 2009
5. CONNECT Coimbatore held at Coimbatore on 27<sup>th</sup> February 2009

## **8. DRIVING LICENCE CARD:**

As per the Government approval, the preparation and issue of Laminated Computerised Driving License was entrusted to ELCOT by the Transport Commissioner in all the 107 centres in the State. During the current financial year (2008 – 2009) the billing is Rs.6.36 Crores. We have allotted 107 centres to contractors M/s UTI Ltd, and Keltron.

## **9. SHARE CAPITAL:**

The paid up capital of ELCOT at the commencement and close of the year is Rs.2593.05 lakhs.

**COMMENTS OF THE COMPTROLLER AND AUDITOR GENERAL OF INDIA  
UNDER SECTION 619 (4) OF THE COMPANIES ACT, 1956 ON THE ACCOUNTS  
OF ELECTRONICS CORPORATION OF TAMIL NADU LIMITED, FOR  
THE YEAR ENDED 31 MARCH 2009**

The preparation of financial statements of Electronics Corporation of Tamilnadu Limited, for the year ended 31st March 2009 in accordance with the financial reporting framework prescribed under the Companies Act, 1956 is the responsibility of the management of the company. The Statutory Auditors appointed by the Comptroller and Auditor General of India under Section 619(2) of the Companies Act, 1956 are responsible for expressing opinion on these financial statements under section 227 of the Companies Act, 1956 based on independent audit in accordance with the auditing and assurance standards prescribed by their professional body the Institute of Chartered Accountants of India. This is stated to have been done by them vide their Audit Report dated 23.09.2009.

I, on behalf of the Comptroller and Auditor General of India have, conducted a supplementary audit under section 619(3)(b) of the company Act, 1956 of the financial statements of Electronics Corporation of TamilNadu Limited, for the year ended 31.03.2009. This supplementary audit has been carried out independently without access to the working papers of the statutory auditors and is limited primarily to inquiries of the statutory auditors and company personnel and a selective examination of some of the accounting records. Based on my supplementary audit, I would like to highlight the following significant matters under section 619 (4) of the Companies Act, 1956 which has come to my attention and which in my view are necessary for enabling a better understanding of the financial statements and the related Audit Report.
