#### NAME OF THE PARTY:

#### <u>LIMITED TENDER</u>

The scope of the DG sets AMC in two parts is stated below for two years.

**Part-A** – This scope covers the work for preventive, breakdown and periodical maintenance (AMC) for 1 No of 250 KVA D.G set with manual control panel and 1 No.of 75 KVA D.G set with manual control panel (Part – A) for 2 years at ELCOT, Perungudi

- b). The Earnest Money Deposit of the unsuccessful Bidders will be returned at the expense of the Bidders once the tender is finalized or acceptance of offer from the successful bidder. The above Earnest Money Deposit held by ELCOT till it is returned to the unsuccessful Bidders will not earn any interest thereon.
- c). Earnest Money Deposit amount of the successful Bidder may be adjusted towards Security Deposit (SD) for successful execution of AMC work and will be returned only after the successful completion of the Contract Period.
- d). The tender received without Earnest Money Deposit will be summarily rejected.

## **SCOPE OF WORK WITH TERMS AND CONDITIONS:**

- 1. Preventive Maintenance (functional checking and necessary adjustments) to be carried out with the presence of ELCOT Officer.
- Maintenance and servicing of DG sets with manual control panel and also replacing the spares those are required during the AMC period, which has to be replaced immediately.
- Any break down maintenance should be attended in the presence of ELCOT officials within Two Hour or Three hour (fault finding, repair of replacement of defective parts and functional checking).
- 4. Any defective part or spare replacement has to be done with the prior intimation and concurrence of ELCOT.
- 5. Providing a service to the DG sets as and when required on free of charge, during repair / overhaul of the DG sets at our office or your service station.
- The AMC covers inclusive of distilled water and maintenance and servicing of DG sets and manual control panel.
- 7. The spares (Part-B) during the periodical maintenance will be replaced for two years (As per the list of spares available in the tender) for 1 No of 250 KVA D.G set with manual control panel and 1 No.of 75 KVA D.G set with manual control panel and there is no exception. The finalized rates for the spares are as per the Part B for 2 years.
- 8. During the defective spares replacement, the prior approval will be obtained from the ELCOT.

- 9. Necessary tools and instruments required for service have to be brought by the Service Engineer (Vacuum Cleaner/ Blower required for cleaning the D G sets).
- 10. During the Preventive maintenance, the DG sets and manual control panel to be serviced completely (i.e. Every Quarter 3 months).
- 11. During the Preventive maintenance and Breakdown maintenance, the spares (Part-B) other than those not covered under the tender should be specifically intimated to ELCOT and specific approval of ELCOT should be obtained.
- 12. The Service Engineer has to be an experienced and skilled resource in providing the perfect service to ELCOT in maintaining the D G sets.
- 13. The Contractor should not sub-contract any work during the AMC period and the contractor will be the wholly responsible at any circumstance.
- 14. ELCOT reserves the right to terminate the contract in case of any defect/default in the execution of AMC.
- 15. Periodical inspection should be done at least one three months and shall confirm the functioning and performance of the DG sets inspection report in the prescribed format has to be submitted to ELCOT.
- 16. Your rate should be inclusive of AMC maintenance service and spares that are required during the AMC period of two years, which has to be replaced immediately.

#### PAYMENT:

- 1. The total cost quoted by the L1 bidder shall be divided into 8 quarters 2024- 2025 and 2025 2026. After completion of every quarter, corresponding AMC payment will be made for that quarter..
- 2. Income Tax, CGST, SGST, TDS and other taxes if any will be deducted as per the prevailing rate on the value of the work done, while releasing the payment.

# SECURITY DEPOSIT CUM RETENTION MONEY

An amount equal to 5% of the value of AMC and Spares cost shall be withheld from the bill and retained for a period of two years i.e. 2024-2025 and 2025-2026. If there are defects noticed within this period (i.e. 2024-2025 and 2025-2026) the same shall have to be rectified by the bidder at his own cost and without claiming extra, the withheld amount will be refunded after end of 2 years from the date of commencement of AMC. The amount so withheld will not carry any interest.

# SUBMISSION OF TENDER:

- B. The Tender must sign and affix his seal in every page of tender document.
- C. The bidder should fill the Part-A (Price bid for AMC) and Part-B (Price bid for spares) of the tender schedule

# **LIQUIDATED DAMAGES (LD)**

A penalty of 0.25% per calendar day of late completion of work beyond the 24 hrs will be levied subject to a maximum of 5% of contract value.

### TERMINATION OF CONTRACT

#### Termination for default

- a) ELCOT may without prejudice to any other remedy for breach of contract, by written notice of default with a notice period of 7 days, sent to the successful Bidder, terminate the contract in whole or part,
  - i) If the Successful Bidder fails to deliver any or all of the goods within the time period(s) specified in the Contract or fails to supply the items as per the Delivery Schedule or within any extension thereof granted by ELCOT; or
  - ii) If the Successful Bidder fails to perform any of the obligation(s) under the contract; or
  - iii) If the Successful Bidder, in the judgment of ELCOT has engaged in fraudulent and corrupt practices in competing for or in executing the Contract.
- b) In the event of ELCOT terminating the Contract in whole or in part, ELCOT may procure the goods and service upon terms and in such manner as deems appropriate at the risk and cost of the defaulting Supplier and such supplier shall be liable to ELCOT for any additional costs for such goods and services. However, the Successful Bidder shall continue the performance of the contract to the extent not terminated.

# TERMINATION FOR INSOLVENCY

ELCOT may at any time terminate the Contract by giving written notice with a notice period of 7 days to the Successfully Bidder, if the Successful Bidder becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Successfully Bidder, provided that such termination will not prejudice or affect any right of action or remedy that has accrued or will accrue thereafter to ELCOT.

## TERMINATION FOR CONVENIENCE

ELCOT may by written notice with a notice period of seven days sent to the Successful Bidder, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for ELCOT's convenience, the extent to which performance of work under the Contract is terminated and the date upon which such termination becomes effective. On termination, the successful Bidder is not entitled to any compensation whatsoever.

#### <u>ARBITRATION</u>

Except as otherwise provided elsewhere in the contract, if any dispute, difference, question or disagreement arises between the parties hereto or their respective representatives or assignees, at any time in connection with construction, meaning, operation, effect, interpretation or out of the contract or breach thereof, the same shall be decided by Sole Arbitrator to be appointed by the Managing Director of ELCOT.

If the Arbitrator so appointed dies, resigns, incapacitated or withdraws for any reason from the proceedings, another Arbitrator shall be appointed by the Managing Director of ELCOT. The Arbitrator so appointed shall proceed with the reference from the stage, where his predecessor had left if both parties consent for the same; otherwise, he shall proceed de novo.

It is a term of the contract that the party invoking arbitration shall specify all disputes to be referred to arbitration at the time of invocation of arbitration and not thereafter.

It is also a term of the contract that neither party to the contract shall be entitled to seek interest and the arbitrator should not grant interest.

The Arbitral Tribunal shall give reasoned award and the same shall be final, conclusive and binding on the parties.

The venue of the arbitration shall be Chennai and language English.

The fees of the Arbitrator and expenses incidental to the arbitration proceedings shall be borne equally by the parties.

Subject to as aforesaid, the provisions of the Arbitration and Conciliation Act, 1996 and any statutory modifications or re-enactment in lieu thereof shall apply to the arbitration proceedings under this clause.

Subject to the above, the Courts in Chennai alone shall have jurisdiction in this matter.

#### COMPLIANCE WITH STATUTORY REQUIREMENTS

You have to comply with the Contract Labour Act, (Regulation and Abolition act), Payment of wages Act, Minimum wages Act, Employees State Insurance Act, Employees Provident Fund and Miscellaneous provisions Act, Fatal Accident Act and other applicable Labour Laws and Regulations in force from time to time.
