Scope of Work

TNMCC has procured two numbers of Video wall (12 ft x 8ft), Controller with Stabiliser, Desktop Computers. 1 KVA UPS provision is made for Desktop and Video Wall Controller (VWC) .

The tender is floated for the Supply, Installation and Commissioning of tendered items for TNMCC

The scope of the successful bidder under this tender are listed below:

1. Supply, Install & Commission of the Ordered items in time.
2. The items shall be supplied & installed as per tendered specifications and in-line with the industry standards. No incompatible or refurbished items shall be supplied. All the
3. Structured LAN cabling to be done with conduit from VWC to Video Wall within the building and Laying in conduit, digging and earth filling as per standards for the cabling outside the building. The total cable laying for each Video wall will be within 100 meters.

4. Electrical cabling work to be carried out for Provision of Power Supply to Stabiliser of Video Wall from nearby Power source. The max distance of Power source shall be of 50 metres. Excavation and refilling shall be carried out if required.
5. Civil Support Structures for Video Wall & Flex boards
6. Flex boards

- 1) **Delivery and Installation:** Within 15 days from the date of issue of purchase order at the designated locations in the premises of High Court Campus as specified by Tamil Nadu Mediation and Conciliation Centre (TNMCC).

2) **Price Bid Evaluation:** The total value including all taxes, duties and other charges for all the items will be taken up for Price Bid evaluation.

- i) The bidder who becomes overall L1 as prescribed in the price bid will be called as L1 bidder.
- ii) However the L1 bidder shall be asked to match the L1 price of the individual item, where they have not become L1.

3) **Validity of the Tender:** 30 days.

4) **Payment Terms:** 100% of the total cost of ordered items will be paid by ELCOT on behalf of the purchaser, after receipt of funds from the purchaser, on delivery on proof of delivery of the ordered items and on submission of Performance Bank Guarantee for 5% of total order value.

5) **Liquidated Damages for Non-Fulfillment of Purchase Order:**0.25% PER Day on the undelivered portion of the value subject to a maximum of 5%, if the supply, installation and commissioning has not been completed in full within the stipulated delivery period.

6) **Penalty for Non-Fulfillment of conditions:**

In the event of non-fulfillment or non-observance of any of the conditions stipulated in the tender document and Purchase order, the successful bidder should pay the penalty amount equivalent to 10 (ten) per cent of total value of purchase order or an amount equal to the actual loss incurred by the purchaser whichever is higher.

7) Warranty:

a) The Tendered items shall be covered with **Onsite warranty for specified period** which includes replacement of any spare parts if necessitated and if the spares are not available then complete replacement of the item(s) with an equivalent/higher/next generation model which is acceptable to ELCOT/End User shall be made without additional cost to the ELCOT/End User.

b) The warranty period shall be calculated from the date of installation / commissioning of the IT products at the last location in the Purchase order evidenced from the date of signature of the End User in the Installation report.

Note:

The Bidder shall submit the offer by filling up all the columns including **Supply, installation, transportation, Testing, commissioning with necessary labour charges. Partial quote is not allowed.** The bidder who becomes overall L1 will be declared as L1 bidder. The L1 bidder will be asked to match the lowest price of the individual items, where they have not become L1.
