SCOPE OF WORK

Electronics Corporation of Tamil Nadu Limited (ELCOT), a wholly owned Government of Tamil Nadu Undertaking invites offers for the Annual Maintenance contract for One years for the computer and other Peripherals and IT products at TNPSC office. The Bidder has to undertake the above said work .The detailed Scope of Work is given below.

1) Bidder should be ready to provide Maintenance of Networking, Computers, Servers, Printers, scanner, Biometric, CCTV and IT products etc

- 2) Bidders should deploy trained and experienced manpower Maintenance of Networking, Computers, Servers, Printers, etc.
- 3) Bidder should ensure that the equipments are in good working condition of the equipment before entering contract period.
- 4) No claim should be made for the standby devices. It is the sole responsibility of the bidder to ensure the working condition of the devices and handling of the equipments at the departments.

The following are the requirements with regard to the AMC of the above said IT products.

Obligation/Terms & Conditions of TNPSC

- 1. The company should appoint Two residential engineers to the Commission's office and they have to work from 10.00 am to 5.45 p.m. on all working days. Further, whenever required, they have to arrive early in the morning and leave late in the evening. Further, as and when required, they should attend office even on Saturdays, Sundays and other Government holidays. The service engineers can avail compensatory off for having attended office on Sundays on rotation basis without affecting the routine functioning of the Commission's office. The Service Engineers shall be required to work a minimum of 26 days in a month.
- 2. The Service Engineers should possess all the required educational, technical and practical experience and should be well equipped to attend all the faults immediately.
- Frequent change of Service Engineer will not be accepted. In case of unavoidable circumstances, change of Service Engineer should be done only in consultation with the Commission.
- 4. The contractor shall not enter either into a sub-contract with any other person/company or transfer the contract or any benefit there under to any other person or company.
 - The contractor must have experience of providing similar services for Maintenance of Networking, Computers, Servers, Printers, etc., to Govt. Organizations /PSU/Nationalized Banks and should be in the field for at least Two years.
 - 6. Preventive Maintenance should be done at regular intervals and report of such Preventive Maintenance should be submitted to the Commission's office. The frequency of such preventive maintenance will be quarterly. Any delay / omission in conducting preventive maintenance exercise during the contract period will attract a penalty of Rs,100 per non-critical equipment and Rs.1000 per critical equipments.

- 7. The contractor should attend to the minor complaints made by the user on the same day. However, all complaints must be attended to within the next day. However, the leeway to take the complaint to the next day cannot be a routine practice and this has to be done only under unavoidable circumstances and with the prior permission of the officials concerned, failing which it will attract a fine.
- 8. In case of major faults, the equipment should be set right and restored to working condition within 24 hours from the time of reporting of the fault. However, after deciding that if it is a major fault, a standby unit or equivalent configuration shall have to be provided within 24 hours by the successful contractor so that the work of that user/section does not suffer. If the faulty equipment is not rectified and installed within 24 calendar days from reporting the fault, the penalty would be levied.
- 9. If any of the problem is not resolved within a specified time limit (i.e., on the same day in case of a minor problem and within 7 days in case of major problems), the Commission has the liberty to get the same repaired by any outside vendor(s) and the cost of the same will be deducted from the Quarterly bill of the contractor.
- 10. The contractor shall keep sufficient number of spares such as Mother Boards, RAMs, Monitors, Hard Disk Drives, Keyboards, Mouse, Cables, Printer / Scanners etc. as standby (a minimum of five numbers of each) to put them in-service whenever required.
- 11. The Commission's office reserves the right to abandon or terminate the contract at any time without assigning any reason, after giving one-month notice to the contractor. In the event of the service / work being found unsatisfactory and / or not according to the specifications and standards laid down in the contract, the contract may be terminated at one month's notice after giving the successful contractor an opportunity to show cause as to why such an action should not be taken. If the explanation is acceptable it may be considered.
- 12. In the event of termination of the contract on account of unsatisfactory / substandard services, the Commission's office shall not accept any responsibility for any loss suffered by the contractor.
- 13. The AMC amount will be released on a Quarterly basis at the end of each Quarter on the satisfaction of the service contract and performance of the work entrusted for the period from the date of execution of the AMC.

- 14. The Contractor while taking over the contractual responsibility, shall undertake a detailed survey of all the assets covered by the AMC with regard to their working condition and quarterly payment shall be claimed (through M/s ELCOT) only for the assets that are in working condition
- 15. The contractor shall be required to hand over all the equipment in working condition at the time of termination/ completion of the contract.
- 16. Any equipment not made available in working condition on the Last day of the contract period shall be rectified /repaired by the contractor within the next three working days.
- 17. The contractor shall provide services for 15 working days from the date of expiry of the contract for smoother transfer of the AMC to the new contractor without any extra cost.

Additional Terms

- i) 98% up-time is expected for Servers & Desktops and immediate backup to be provided. Replacement of parts for servers should be top priority and such replacement to be done within 24 hours for desktops & Servers and 48 hrs for printers..
- ii) Company should inspect the entire Hardware and its configuration details before entering the contract and record the details of the configuration.
- iii) The Company should record the Stock No. and Serial No. of Desktops/Printers in advance so as to ensure call logging/resolution of complaints of all such stock. Refusal to attend to complaints stating Serial No. mis-match of stocks at any later stage will not be entertained and Company to resolve such complaints mandatorily.

PAYMENT TERMS

- 1. No advance Payment will be made.
- The AMC amount will be released on a Quarterly basis at the end of each Quarterly period of the service contract and on satisfactory performance of the work entrusted for the period from the date of execution of the AMC.
- 3. Payment will be released based on the completion of work and subject to submission of bills

- 4. Penalty amount if any for delayed completion of work will be adjusted in the payment due to the successful bidder.
- 5. All taxes and other levies imposed by Governments in India will be paid at actuals as applicable.
- 6. Bidder shall have exclusive liability for remittance of Taxes to State and Central Governments as per the Statutes/Act ruling now or hereinafter enforced.
- 7. Payment will be made only on receipt of funds from Departments concerned.

PENALTY CLAUSE:
