





ELCOT has implemented an online single window portal for granting permission to the Telecom Service Providers / Infrastructure Providers (TSPs/IPs) and is operational since 24.11.2020. The portal is also integrated with e-Challan facility & PayGov Payment Gateway with effect from 22.12.2022.

In order to maintain sustainable study and arrive at modalities for smooth implementation of 5G Roll out and a better monitoring of Telecom Infrastructure, ELCOT proposes to engage One Consultant (Telecom) on contract basis.

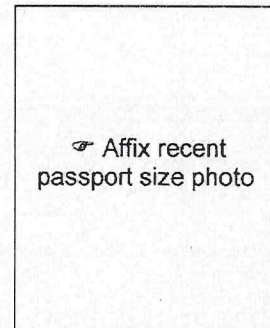
