One major services BTH provided was for providing PDI Inspection services to TNCSC through about 3 dozens of Inspection Engineers throughout the Southern states as well as many states of India where manufacturing units were located.</p> <p>Presently the Internet services have been suspended in many parts of Haryana and adjoining areas of Delhi due to ongoing farmers agitation due to which there is no possibility of using the internet. You will be aware that there are many labs are situated in Haryana, Punjab, UP, Delhi-NCR who would be eligible for this tender but may miss the opportunity to apply online through EPROC.TN portal. The day-to-day operations of all the organisations in the above areas are disrupted for want of regular, high speed internet services.
