ORDER:

Land measuring 28.91 acres at Ilandaikulam Village, Madurai District, 239.58 acres of land at Vadapalaniji and Kinnimangalam villages of Madurai District, 135.04 acres of land at Navalpattu Village in Trichy District and 164.26 acres of land at Jagir Ammapalayam Village in Salem District have been alienated in favour of ELCOT for the establishment of IT Parks. Similarly, ELCOT has purchased 500 acres of land in Tirunelveli Gangaikondan Industrial Growth Centre from SIPCOT.

2. Based on the decision of the meeting held by Chief Secretary to Government on 17.4.2007 and based on the circular resolution No.6/2007, 9/2007 and 21/2007 of the Board of ELCOT, the Managing Director, ELCOT has sent proposals to Government for allotment of land to the following IT /ITES Companies in the ELCOT promoted IT Parks on 90 years lease basis at the following rate:

The MD, ELCOT is also permitted to lease out the land for 90 years to the companies specified above at the rates fixed therein subject to the following conditions:-

- To charge the rate of land cost as indicated above per acre on net extent of land leased out to the IT/ITES Companies.
- To collect the cost of the development of roads within the SEZ in terms of laying of roads, sewerage disposal facilities etc., from the companies on a pro-rata basis
- The allottees shall use the land only for the purpose of IT/ITES and they shall not use it for any other purpose.

5. The Managing Director, ELCOT is directed to take further action in the matter with reference to the orders in paragraph 4 above.


